# **PRODUCT INFORMATION**

#### **DESCRIPTION**

Fireshield® TimberOne Topcoat is a is a waterborne transparent coating used to protect Fireshield® TimberOne intumescent when:

- · Humidity is >75% RH constantly or
- · When a wipeable surface is requried.

Fireshield® TimberOne Top Coat is available in a matt finish (7 GU at 60°)

#### **RECOMMENDED USE**

Fireshield® TimberOne Topcoat is an industrial product and can only be applied by Registered Applicators, in particular:

- Fireshield® TimberOne Topcoat provides a sealing coat to protect the TimberOne intumescent basecoat.
- All timber surfaces must be coated with the correct film thickness as scheduled to achieve the required Group Surface rating.
- The recommended 100µm wet film thickness can be achieved in one coat with an airless spray unit.
- For best results do not exceed the recommended film thickness.

#### PRIMERS/STAINS

Not recommended for use with any primers or stains.

#### **TOPCOATS**

Fireshield® TimberOne is only compatible with Fireshield® TimberOne Top Coat matt provided by Fireshield.

### **MAINTENANCE**

The system has the ability to resist minor contact with moisture, impact and abrasion however, excessive wear or moisture contact may damage the system and if so, require inspection and possible remediation. A copy of the Fireshield® Timber Coating Maintenance Guide is available from Fireshield®.

# LIMITATIONS

- The wood-based substrate must be ≥ 8mm or thicker and have a density ≥ 338kg/m³
- For interior use only in dry, C1 zones. Contact Fireshield® for C2/C3 zone requirements.
- Only use with Fireshield® TimberOne basecoat.
- Do not use in external applications!

# **DRYING TIMES**

At a wet film thickness of  $100\mu m$ , a minimum air temperature of  $23^{\circ}\text{C}$  and relative air humidity of 50% the following drying times are applicable:

- 1 hour to touch dry and
- 2 hours dry to handle.

**NOTE:** Dry times may be lengthened by poor air flow and environmental conditions differing from those listed above, which are a guide only.

### STORAGE CONDITIONS

Recommended storage conditions:

- Store at a temperatures above +5°C and below +35°C
- Store indoors and undercover in temperate conditions.
- Store away from direct sunlight, do not expose to extreme heat.
- Do not allow to freeze.
- Keep containers closed when not in use.
- · Keep out of reach of children

#### SHELF LIFE

12-months at +25°C if stored in original sealed containers under recommended storage conditions listed on this TDS. Do not use product that is beyond the manufacturers shelf life date shown on the bucket. Contact Fireshield® if in doubt.

#### **APPLICATION NOTES**

The product must be applied in strict accordance with the Fireshield® application instructions. In particular the Applicator should ensure:

- The surface to be coated is completely clean and dry. Remove all dust, oil, grease, loose material or other contaminants.
- The product is occasionally stirred while using.
- Application occurs using suitable equipment for the substrate, working conditions and desired finish.
- Apply at a distance of approximately 40-50 cm from the surface.
- Fill out Daily Record Sheets and PS3 for compliance sign off at the conclusion of coating process.

#### **PRECAUTIONS**

The following precautions must be taken:

- Read the Fireshield® TimberOne Top Coat Material Safety Data Sheet (MSDS) before application and have a copy available on site at all times.
- Read the Fireshield® Timber Application Guide in full before application.
- All work involving the application and use of this product should be compliant with all relevant National Health, Work Safety & Environmental standards and regulations.
- Where conditions may require variation from the recommendations on this Product Technical Data Sheet contact Fireshield® for advice prior to painting. Do not apply in conditions outside the parameters stated in this document without the express written consent of Fireshield®.

# APPLICATION ENVIRONMENT

During application and drying, day or night ensure that:

- The air temperature is above +10°C and below +35°C.
- The relative air humidity level is below 75%.
- The area is well ventilated with constant air flow/air changes.

During application or drying protect from wetting/moisture/condensation and human impact. Electric heaters and dehumidifiers can also be used to help control the environmental conditions if necessary.

#### **APPLICATION METHOD**

#### **Airless Spray**

Airless spray is the recommended method of application and gives the best result.

Airless Equipment Recommendations

= -		
Pump flow rate	5 litres per minute. E.g Graco MkV	
Hose Diameter	Dedicated hoses not below 3/8"	
Spray Tip	Orifice size range of 511 to 517 tip size. Choose appropriate fan width depending upon substrate) to be coated 30° - 60°	
Pump Pressure	1750-2350 psi	
Heated hose or in-line Heater	Optional: Can be used in colder conditions to maintain product at room temperature to a maximum of +30°C.	

#### Brush

Brush application not recommended. For small areas or touchup care must be taken to achieve the required specified dry film thickness.

#### Roller

Roller application not advised, if used only suitable for small areas or touch-up and may result in a textured finish. Care must be taken to achieve the required specified dry film thickness, apply a thin coating without re-rolling on an already painted surface. Let dry, then apply layer two in the same manner for full coverage.
